- Consider, monitor or evaluate their own approach to quality assurance;
- Examine how other Member States and VET providers in Europe are operating a quality assurance system;
- Explore ideas relating to the design of a national, regional or an institution quality assurance system;
- Stimulate further thinking on how to introduce or develop quality assurance mechanisms at a system or VET provider level.

## Who are we?

The EQAVET Framework (developed by Member States in cooperation with the European Commission and adopted in 2009 by the European Parliament and the Council) is designed to promote better VET by providing authorities and providers with common tools for the management of quality in VET. It is a key element in the follow-up to the Copenhagen Declaration, which calls for closer cooperation in the field of VET and in on-going work to renew Europe's education and training systems.

Given the diversity and complexity of VET systems and of the approaches to quality within and across Member States, the EQAVET Framework offers a common point of reference to ensure transparency, consistency and portability among the many streams of policy and practical development across Europe, in order to increase mutual trust and mobility of learners and workers.

In each Member State a Quality Assurance National Reference Point (National Reference Point) has been established, in order to support the use and implementation of the EQAVET Framework, which is voluntary.



## Using the EQAVET Quality Cycle – core functions and utilities

On entering the EQAVET Quality Cycle, you are presented with a choice of whether to explore quality assurance for VET systems or for VET providers.

**Within each of these sites, there is a common structure which includes:**

- guidance on a set of quality criteria or Indicative Descriptors of the EQAVET Recommendation and Building Blocks which offer practical advice on what could be done to develop quality assurance;
- guidance on the Indicators of the EQAVET Recommendation;
- an extensive collection of Case Studies demonstrating how Member States and VET providers in Europe have approached quality assurance;
- a glossary of key terms and information sources used in a VET quality assurance context;



## Building your system

This section offers support to those introducing or modifying a national or regional approach to quality assurance. It focuses on:

1. The EQAVET Indicative Descriptors for the four stages of the Quality Assurance Cycle (planning, implementation, evaluation and review). It contains a series of 'contrasting statements' for each Descriptor, which invite you to consider which of the two statements best describes your own system, supporting a process of self-reflection in order to stimulate change.
2. Showing links to appropriate EQAVET Indicators which may help you to improve your performance as measured by these Indicators within a quality criteria area described by a Descriptor.
3. A set of 10 Building Blocks which offer practical advice on what could be done to develop quality assurance for VET.






## Monitoring your system



The EQAVET Quality Assurance system for vocational education and training is based on the 2009 Recommendation from the European Parliament and Council. Currently VET providers are using many different approaches to quality assurance. Some of these are in line with national or international systems. Others have been designed to meet the VET provider's own circumstances. EQAVET is not just another quality assurance system - it is the one that has been accepted by Member States. As such it is supported by the Quality Assurance National Reference Points across Europe. It is a comprehensive system that offers VET providers a straight forward way to monitor and improve the quality of their provision. It is based on the four stage cycle of planning, implementation, evaluation and review which is at the heart of many other quality assurance systems. This web resource provides guidance on how to develop a quality assurance system and contains examples of different approaches used by VET providers.




